ELIGIBILITY: All swimmers must have an active registration with U. S. Masters Swimming at

the time of registration. No exceptions. Each swimmer is responsible for their proof of USMS registration and may be required to show it upon request.

SWIMMERS MUST VERIFY THEIR USMS MEMBERSHIP DURING ONLINE & DECK REGISTRATION. Deck entry forms should display your name and USMS number as it appears on your registration records with USMS. All swimmers shall

represent their USMS Club and not their Workout Group.

AGE The age reported on your entry form must reflect your actual age as registered

with USMS. A swimmer's age on December 31, 2025, determines their age for

this meet.

MEET ENTRY
DEADLINE &
DECK ENTRIES:

The meet entry deadline is **Saturday**, **July 19**, **2025 at 12:00 p.m.** Deck entries for <u>all events</u> will be accepted until **Sunday**, **July 20**, **2025 at 7:30 a.m.** provided there is room available. Any entry received after the entry deadline will be considered a deck entry and will be placed in the meet in the order it was received. There is a \$10 surcharge for all deck entries.

RELAY ENTRY:

Relay teams may be entered as MEN, WOMEN, or MIXED. Teams of all types will be seeded together in the same heats and scored separately. A swimmer may not swim on both a mixed and a same-sex team in the same event. All relays will be deck seeded. Relay cards are available online here or can be picked up from the Clerk of Course table by a coach or USMS Club representative. Each card shall include each swimmer's info in order swum on the relay; first name, last name, meet age, and sex. The total age of the four relay team members shall determine the age group in which the relay competes.

Relay cards should be returned to the head table by no later than 7:40 a.m

There shall be no "exhibition" relay swims.

RELAY CARD SUBMISSION:

Relay cards for event #1 should be returned to the Administrative Referee no later than 7:30 a.m. Relay cards for events #7 and #8 should be returned to the Administrative Referee no later than the conclusion of event #4.

PARTICIPANT WAIVER

All participants must sign and date the PARTICIPANT WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT.

SEEDING & LANE ASSIGNMENTS:

The meet will be seeded by the pre-entered seed time of each swimmer or relay with the SLOWEST HEATS FIRST. Proof of time may be requested. A seed time of no time (NT) will be seeded in the slower heats. Swimmers will be seeded according to time, regardless of age/gender. Final heat and lane assignments will be posted by 7:55 a.m. at the venue on the day of the meet. Swimmers are responsible for reporting to the blocks when their heat is called.

MAXIMUM ENTRIES: All swimmers are eligible to swim a maximum of 5 individual events for the entire meet, plus relays.

EVENT ENTRY LIMITS:

RELAY EVENTS #1, #7, AND #8 ARE LIMITED TO THE FIRST 20 ENTRIES.

INDIVIDUAL EVENTS #2-6 WILL BE LIMITED TO THE FIRST 50 ENTRIES.

Swims that meet the requirements of USMS Rule 105.2.2, lead-off splits for **SPLIT REQUESTS:** relays will be submitted to USMS for all lead-off swimmers.

> Final results will indicate splits for all swims (excluding pad malfunctions). Splits will be recorded for all swimmers and submitted for records and Top 10 consideration, for initial distances of:

- 800-meter freestyle relay
 - initial distance 100 and 200 meter freestyle
- 400-meter freestyle relay
 - initial distance 100 meter freestyle
- 400-meter medley relay
 - initial distance 100 meter backstroke

Therefore, swimmers need not submit split requests for the events listed in this paragraph. Split requests are required for initial distance(s) of an individual backstroke event. The swimmer is responsible for picking up the Split Notification Form from the administrative official, filling it out, and presenting it to the administrative official prior to the swim. Automatic split times will be submitted for USMS Top 10, however automatic split times from individual events will not automatically appear in the USMS event results database.

Initial distance split requests of 50m distance will not be considered for Top 10 or records in accordance with 103.18.5.

CHECK-IN:

All swimmers shall check in at the front gate of the club upon arrival at the facility. Swimmers who deck enter shall be required to have the complete entry form filled out and signed before they enter the pool for warm-up.

WARM-UP PROCEDURE: Swimmers must enter the pool feet-first in a cautious manner. Diving shall be permitted only from the blocks in lanes 9 and 10 from 7:40 until 7:55 a.m. No diving in the 25-yard warm-up pool.

PROTESTS: Any protest concerning, eligibility, entries, seeding, or final results will be

addressed to the meet director or referee. The protest shall be made by the team

representative only. (USMS rules 102.14).
