Please state why you are interested in serving on the USMS Board of Directors.

I have been a member of USMS since 2003 and hope to help guide the organization into a successful future based on the ideals and goals of the original founders. Discussing USMS with the children of June Krauser ha given me a unique insight into the early days of USMS. Recognizing that much has changed about USMS since the 70's, the inspiration that so many received to volunteer is something I would like to emulate in furthering my volunteer work for the organization.

What does USMS's mission mean to you? Please share a personal story.

The mission of USMS means that we are here to expand the adult swimming experience at all levels of experience, keeping in mind that the diversity of the opportunities available to us should benefit the entire body, not just through one perspective.

My personal story with USMS began 27 years after my D-1, National Championship experiences. I fell in love with the personal-relationship aspect of the organization, after experiencing the intensity of NCAA D-1 swimming. The competitors enjoy each other's company, thrive in the health benefits of swimming, and value the commitment that these individuals give to the organization. Our volunteers are the backbone of USMS, and need to be treated as such.

What do you consider to be USMS's greatest opportunities for the next 2 to 4 years? How would you advocate for these opportunities on the national board level?

I believe that we need to have a better auditing system for our College Club Swimming graduates. These are the athletes that, once life settles in for them a bit, will represent the biggest area of growth. While expecting them to immediately join USMS after college is not realistic, it is a source well worth tapping into for the long term health of USMS. Historically we have always had our mid range age groups as the largest percentage of our membership. If we can tap into the athletes in their mid-to late 30s more effectively, I believe that will be our best area for growth.

In recent years, many long-time members of USMS have voiced their feelings that the volunteers have not been appreciated as much as years past. I hope to help revive the passion to volunteer, as many of the LMSCs are struggling to fill all positions. When we celebrate and encourage the passion and time they give, the desire to volunteer will be infectious.

A perfect example was my initial response to the Grown-up swimming acquisition. While initially opposed to it, hearing some of the feedback from individuals supporting it on why the decision was made and re-reading our Mission Statement, I feel now that the program fits nicely into our organization as a stand-alone effort to reach out to adult swimmers and increase the viability of USMS, while offering the benefits that USMS provides.
