I began my volunteer path with the Georgia LMSC and discovered I also had interest in serving at the national committee level. Since moving to the San Fransisco Bay Area in 2018, I have been heavily involved with governance of my local team, Walnut Creek Masters, as well as Pacific LMSC. It has been such an honor over the years to serve our organization as a volunteer. I can think of no greater privilege than the opportunity to give back to USMS by serving on the Board of Directors and sharing my passion for this sport we call our own.

What does USMS's mission mean to you? Please share a personal story.

I believe our mission captures the essence of helping our members to become stronger and more confident as they seek to improve the quality of their lives through swimming. That quality-of-life improvement can mean different things to different people. By building a swimming community that encourages everyone and addresses their own needs, USMS can provide a swim home for everyone. Case in point, is my own USMS journey. I am a somewhat "late bloomer" to the swimming arena. I grew up dedicated to a different sport and only ventured into swimming later in life due to back and knee issues. In 2011, I joined this quirky local

adult summer swim league in Atlanta, GA (now called Grown Up Swimming). When the summer was over, not only did I find that my physical ailments were non-issues, but I discovered a passion for swimming (and competing). Adding to that, a community that supported me not only while in the pool but cared about my general well-being. Despairing at the possibility of not swimming again until next summer, a friend suggested that I join US Masters Swimming. Of course, my brain went to the "green jacket" of the golfing world and didn't think I was of the caliber to be a "Masters" swimmer. Happy to say my perspective has changed quite a bit over the years and I couldn't be happier than to be part of the USMS family.

What do you consider to be USMS's greatest opportunities for the next 2 to 4 years? How would you advocate for these opportunities on the national board level?

As I look at the landscape of opportunity for USMS, there are so many good efforts being made (too many to mention here). I think we need to focus on shaping our organization for the future and broadening our scope for membership growth and development. With Grown Up Swimming now under the USMS umbrella, this seems like a tremendous chance to help build a potential bridge to USMS membership and promote swimming as a community effort. As a member of the Grown Up Swimming Advisory committee, it has been such a pleasure to see this product launch and am excited to see where this effort takes us. In addition, College Club Swimming seems to be an avenue for greater membership growth. For both Grown Up Swimming and College Club Swimming, it seems we also have potential for expanding our demographics to a much broader audience along with increasing our member base (i.e. add more diversity to our membership). Being on the national board, I would seek to gain a deeper understanding around these efforts mentioned and help identify gaps for support along with promoting best practices for sustainment.

In a recent monthly LMSC meeting, a topic came up that surrounded a potential legislation change that will most likely be presented during the annual USMS meeting in September. Unfortunately, this topic never made it to the agenda due to a miscommunication that was completely my fault. The topic was added as an addendum at the beginning of the meeting, but no one had the opportunity to review the legislation change beforehand. Thus, we needed to spend time during the meeting to review the language and give everyone present the opportunity to express their opinions and engage in discussion. Using Robert's Rules of Order as a guide to facilitate the conversation, attendees spoke one at a time and all respectively listened to what others had to say. Even though our meeting lasted a bit longer than normal, we were able to successfully navigate the discussion, ensuring all had a voice and brought closure to the topic.
