Please state why you are interested in serving on the USMS Board of Directors.

I have always loved swimming, the sport has given me so much and I have endeavored to give as much back as I can. I first became involved with USMS through the NC LMSC; after attending my first annual meeting I knew that I could make a difference for our sport. Meeting so many like minded people as well as many people that challenge my viewpoint has broadened my view of Adult swimming and what it could be. I primarily viewed swimming as a competitive only sport when I first formally organized our USMS team (the Gaston Gators). I have come to embrace ALTS, Fitness Swimming and everything in between. I am proud to have a diverse program that includes competitive swimmers, fitness swimmers, and ALTS graduates all swimming under the same banner. I think of my team as a microcosm of all the great things I know USMS can be. I want to bring that feeling of team, of family and of the love of swimming to the USMS Board. I will make every effort to serve the mission of USMS, strive for new ground and focus on the most important part of all. The people. Without the members, the teams, the coaches on the ground, we are nothing. I hope you will consider me to represent the Southeast Zone as an At-Large director to the best of my abilities.

What does USMS's mission mean to you? Please share a personal story.

I have seen full well how USMS has empowered people around me. My assistant coach came to swimming through wanting to complete a triathlon. Since 2012 I have watched her grow into a competitive swimmer, competing in her first meet in 2014, and her first Nationals in 2016. She continued to grow in the sport, becoming a USMS Certified Level 1/2 Coach in 2017, and achieved Level 3 in 2021. She also received her

ALTS Instructor certification in 2017 and has taught over 50 adults to swim since that time. I couldn't be prouder of her and what she has achieved. Coming from a newbie triathlete to a seasoned coach and instructor has been the truest definition of an adult empowered through swimming that I have ever witnessed. She is even dipping her toe into the Age Group pond and applying for a position as a High School Coach in the Fall!!

What do you consider to be USMS's greatest opportunities for the next 2 to 4 years? How would you advocate for these opportunities on the national board level?

The greatest challenge and opportunity facing USMS currently is membership. From clubs that don't require membership to our largest cohort aging through the sport (and eventually aging out), bringing new swimmers to the fold is our number one priority. I believe this begins with community, building programs and interest from the ground up. Finding ways to remove the "stigma" of competition and show people that a swim meet doesn't have to be an hours long stressful affair. There is a place for Nationals, for State Champs and the like. They are going strong and continue to attract competitors (though generally not "new" ones). We can strive as an organization to bring more people into the fold through smaller community events and elevate them up to that level. Grown Up Swimming is a good start if handled and marketed correctly. We also need single day "Fun Meets", "Relay Festivals", ALTS Events, and the like. Support from the national level to grow events for teams that have never hosted them is key. Encouraging LMSC's that have the funds to subsidize competition and make sure that the members' money goes back to serving those same members, not just sitting in a "Rainy Day Fund". At the end of the day, serving the swimmer (member) must be our top priority.

What makes you a good candidate for a USMS at-large director? What skills, experiences, and attributes do you have that will contribute to the success of USMS?

I will serve the board if elected as a coach first and foremost. Listening, providing strategy and correction where I can, deferring to the needs of the member (swimmer) above all. I will do my research, use the best information I can find to provide guidance for the organization going forward, and listen and take feedback when I go astray of the member's needs. Should I be elected, I will be an advocate for the members of the southeast zone, bringing the concerns, suggestions, ideas and vision of those great members to the board as a whole. I will compromise when needed and stand my ground if I feel that it is needed. I have never been accused of being a "yes man", though I have been called a "team player". I will strive to find the balance between supporting the vision of the organization and challenging things that I find to be leading us outside the lane lines.

Describe a situation where you had to balance your own perspective with input from individuals representing various viewpoints, and how you ensured that all perspectives were considered.

I call a common situation that arises in my professional life "the great relay conundrum". In meets as a coach one must weigh the points that relays earn, against the strain on the swimmer eyeing personal best times in individual events. This past April I had to juggle 16 swimmers, trying to provide everyone with A)equal work load, B)separation from their target events, and C)fielding this best possible relay. I work with my swimmers to understand the most important personal goals they have, express to them my goals for the team as a whole, then work back and forth with them to find the best combination. This is not without strife. Sometimes I push too hard and my swimmers don't want to let me down, other times I don't push hard enough and learn after the fact that I could have asked more of them. I seek this type of balance on the deck in my coaching life and will bring the same to the board. I will hear all perspectives, present my own, and seek the middle ground betwixt them that works best for the team (board) and it's current goals.
