Please state why you are interested in serving on the USMS Board of Directors.

In my involvement with USMS, as a swimmer, a coach, and a volunteer, I have discovered that the more I give back to USMS, the more I get out of it. I enjoy serving USMS as a volunteer at the local and the national level, and I feel that my skills doing community outreach and project management in my day job can be an asset to the Board of Directors.

Please share a personal story about what USMS's mission means to you.

The USMS mission, "Empower adults to improve their lives through swimming," can be a life-changing opportunity. I am passionate about Adult Learn to Swim (ALTS). In my community there are underserved populations that have never had the opportunity to learn to swim or even get in a pool. My LMSC, Minnesota, has a women-only ALTS program, originally set-up to teach Muslim women how to swim. I have been fortunate to have led or been in the water for several sessions of this program. Muslim women must be in a women-only environment, and most are fully covered in the water (head covering, long sleeves and leggings.) The participants are so joyful to have the opportunity to get into a pool, and even more so to be able to learn to swim. The participants have said that this ALTS opportunity has changed their lives. They have more confidence and they have a new life skill (especially important in the Land of 10,000 Lakes), and they now have a new way to improve their health through swimming. Several mother/daughter or sister/sister combinations have participated. The experiences that I have had through these ALTS classes have been the most impactful swimming experiences that I have ever had in my 50+ years of swimming.

What do you consider to be USMS's greatest opportunities for the next 2-4 years? How might the Board support these opportunities?

As the USMS membership continues to age and membership retention remains low, we need to focus on attracting younger members and keeping them. College Club Swimming (CCS) and Grown-Up Swimming (GUS) can be prime vehicles to attract and retain the younger demographics. USMS needs to devote the appropriate resources, both staff time and financial, to the programs to continue to develop them and strengthen the links to make the transition between them and USMS effortless and appealing. In addition, the spotlight on swimming will begin to shine as the 2028 Olympics in Los Angeles approach. USMS needs to capitalize on the popularity of swimming that comes with the Olympic Games and the bonus of the Games taking place in the United States. USMS needs to utilize the relationship with USA-Swimming as well as those former Olympians that are USMS members to promote swimming and drive membership and potentially the addition of new Masters clubs. ALTS continues to be a huge opportunity to spread our mission of empowering adults to improve their lives through swimming. We all know adults who don't know how to swim. ALTS is a program that helps make adults safer in the water. The USMS Board and its members need to continue to support the ALTS effort through raising funds for ALTS grants/programs, holding instructor certification and ALTS classes and increasing awareness of the program.

What makes you a good candidate for a USMS vice president? What skills, experiences, and attributes do you have that will contribute to the success of USMS?

I believe that my range of experiences within USMS combined with my personal skills help make me a good candidate for the USMS Vice President of Programs. I have participated in USMS as a pool and OW swimmer, a coach, an official (a new one!), an ALTS instructor, an LMSC leader/Board member and a member of the USMS Board of Directors. While I have served on the Board of Directors previously, I believe that it is important to have a balance of new Board members along with those that have a more in-depth knowledge of the Board and can serve as a resource to the newer members. My personal strengths of leadership, flexibility, attention to detail, communication, listening skills and teamwork/relationship building will allow me to successfully work with the Officials, Long Distance, and Championship Committees and advocate for them so that they can work effectively with the Board of Directors and contribute to the success of USMS.

Describe your experiences within or outside of USMS that would help you act as a liaison to the standing committees overseen by this position.

As Vice President of Programs, I would oversee the Officials, Championship, and Long Distance Committees. Over the last 19 years as a USMS member, my swimming and volunteer experiences have enabled me to become familiar with these committees, either on an LMSC or national level. I am an official and have worked closely with the Officials chair at my LMSC. I have competed in and served on the host committees for both OW and pool national championships, so I have had frequent interactions with member(s) of those committees during the planning process for those events. Combined with my USMS experiences, my work background provides a strong foundation for this Board position. I have been the project manager of multifunctional teams for large companies as well as small non-profits, responsible for completing projects on time and on budget. In this role I strived to guide my teams, whose members have had different personalities and areas of expertise, to work together to achieve common goals. My communication skills and the ability to consider situations and diverse opinions and options when making decisions will be important. Finally, as

Secretary of the USMS Board of Directors for the last 4 years, I have been able to learn vicariously about the roles of the VPs while attending Executive Committee meetings, and I look forward to being a voice these committees.
