Topic: LDC Meeting – January 23, 2025

The meeting was called to order at 8:00pm ET:

Call to order

Welcome and roll call Reports:

Chair – Catherine: Surcharge OWNC

- One Hour Virtual Championship is wrapped up. Over 1400 entries with Oregon having over 400. Discussion of new procedures for finishes in the 1 Hour. Jim will be presenting rules. Dave will discuss subcommittees and goals. 5K and 1mile swims in Sarasota as of today have 141 entries.
- Proposal to increase the swimmer surcharge in OWNC to \$8.00. Current surcharge is \$3.00. Prior to 2025 a \$5.00 surcharge per entrant was paid by the host to the LMSC. This surcharge has been eliminated along with the OW sanction fee. The increase will assist in covering NO expenses of liaison travel, caps, banners and event promotion. There is no surcharge for no-shows and swimmers in multiple events only charged once.
 - This will be tabled until the next meeting
 - Jay will get more information
 - This would be effective for 2026.
 - Our committee can make this decision together with the national office. Does not need to go to the HOD.

Vice Chair – Dave: Sub-committee

- Portland Bridges Swim (Ultra-marathon Swim) is sold out (100 swimmers) and taking a waiting list. Talk to everyone on Sunday evening.

- Needs to be submitted in June, so we have time to look at them.
- 301.2: this has more to do with process, delete.

- Motion to delete (Catherine, second by Dave B). The documents will be maintained separately, but removed from the rulebook.
- o In favor: 9 / Opposed: 0
- 301.1: safety plans need to be approved by Dave Miner. Just clean-up
 - Motion (Catherine
 - o In favor: 9 / Opposed: 0
- 303.4: swimwear for event should be in the event information, particularly for championships.
 - Motion (Nicki/Vesna)
 - In favor: 9/ Opposed: 0
- 303.5: suggestion about how seeding might take place. Want to clarify that this will be up to host.
 - Motion (David/Marnie)
 - Need a motion to amend. Delete, "without times," from the rule (Catherine/Vesna)
 - Voting on the amendment: In favor 9 / Opposed
 - As amended voting: In favor 9 / Opposed 0
- 306.6.3: goes along with the next change. We have a rule on how times are adjusted based on decimal or not. If someone wants to apply for a record, they have to use their official time
- 308.1.4 B & C: adjusted time is the official time.
 - All 3 of these items are grouped together
 - Adding C, the official time must be less than the existing record. So if someone swims a 5k without a decimal, .9 is added to it.
 - Times submitted need to be in the proper format, and they need to be that way to set a national record.
 - In favor: 9, opposed 0

- 306.10.2: for non-championship events, the host must ask the LD Committee for clarification to disqualify. For national events, any issues would be handled by the national office with the LD Committee
 - Motion (Catherine/Marnie)
 - In favor: 9, Opposed: 0
- 307.2.2: this is a process change. Gives the LDC the latitude to identify the open water events for a particular year. It specifies that at least three open events will be held each year. This leaves the criteria for All-Americans intact. It also preserves the character of the current open water event definitions while allowing the LDC the ability to identify other events
 - o In favor: 9, opposed: 0
- 307.4.1c: Performance bond is no longer required, deleted from rules.
 - Motion: (David/Nicki)
 - In favor: 9, opposed: 0
- 307.3: rule about site selection, table, etc. this is more of a process for LDC, so removing these requirements from the rules. This could go into a procedure.
 - Motion (Nicki/Bob K)
 - Discussion: Dave: when we present to HOD, we'll do our best to spread out. But sometimes only a few bids are submitted.
 - In favor: 9, opposed: 0
- 307.7.1: deletes the requirement that the swimmers' names in the result appear as on membership card. It has never been enforced.
 - o Motion: Verna/Nicki
 - In favor: 9, opposed: 0
- 307.7.2: eliminates the requirement for the order of genders in which the results are shown. No reason to require an order, will be left up to the host.
 - Motion: Dave/Marnie
 - In favor: 9, opposed: 0

- 307.8.3: club scoring. Removes the requirement for divisions. Divisions may be recognized. Leave this up to the event host. If division makes sense, then do it. Otherwise, not necessary.
 - Motion: Verna/Dave
 - In favor: 9, opposed: 0
- 307.9.4: this is not a rule. This can be left up to the LDC. Rule not necessary. The LDC can develop a procedure for making awards
 - o Motion: Dave/Nicki
 - In favor: 9, opposed 0
- 307.10.3: easy for the LDC and PARA committee to compile a list of all-Americans. One less thing for a host to do. Deletes requirement for the host.
 - o Motion: Dave/Nicki
 - o In favor: 9, opposed: 0
- 307.11.2: stating that in order to qualify for all stars, the events have to be national championship events (not any open water or virtual event)
 - Motion: Nicki/Dave
 - In favor: 9, opposed 0
- 308.1.5: for USMS record, adding a requirement that a cable event needs an Application for a Cable Event Record to apply for record
 - Motion: Dave/Verna
 - In favor: 9, opposed: 0

Goals: Old Business -

1. Develop a plan to increase the number of overall USMS sanctioned open water events. Clarify OW strategy between LDC and NO.

- 3. Look for more prominent venues for Open Water National Championships
