Minutes

The meeting was called to order at 7:31 pm Eastern time.

- 1. The previous minutes were approved. (unanimous)
- 2. MSA to remove the Part 2 Reorganization from the table. (unanimous)
- 3. Discussion of the Part 2 Reorganization. The Legislation Committee confirmed their opinion that a reorganization of the rule book should be done as a whole and not piece by piece. Concern remains about moving 201 into the Bylaws. Motion to recommend the reorganization of Part 2 fails (0 15). The Part 2 Reorganization will **not** be recommended to the House of Delegates.
- 4. Discussion of Steve 1. MSA to add the phrase synonyms. MSA to add Heat Sheet to the glossary. MSA ro recommend Steve 1 to the House of Delegates.
- 5. Discussion of Rules 1. Discussion of whether to remove the word "Representation" here and possibly in other locations. It was decided not to amend the proposal. MSA to recommend Rules 1 to the HOD. (unanimous)
- 6. MSA to reconsider Kris 6. A revision of the Rationale was suggested and the word "club" was added. MSA to recommend Kris 6 (as amended) to the House of Delegates.
- 7. The Chairman discussed some details about the upcoming virtual convention and the need for all voting delegates to have a Zoom account. Non-voting delegates will be able to view the meeting via live stream.
- 8. The meeting was adjourned at 8:47 pm eastern time.

Motions Passed:

Steve 1 - Moved, seconded and approved to recommend Steve 1 to the House of Delegates

Add to Glossary:

Meet Program (Heat Sheet)—synonyms for the published order of events, heat and lane assignment of participants, and other day-of-race information pertaining to a specific competition.

Heat Sheet-see Meet Program.

Rationale: This addition defines two terms that do not currently exist in the Glossary. The term "heat sheet[s]" appears eleven times, only in Parts 1 and 2 and Appendix B. The term "program[s]" (with respect to meets) also occurs eleven times.

Rules 1 Moved, seconded and approved to recommend Rules 1 to the House of Delegates.

201.3 Representation/Club Affiliation

Rationale: Include "affiliation" in the title, because the article discusses representation for clubs with which a swimmer affiliates and further discusses club affiliation and transferring affiliation.

Kris 6 Moved, seconded and approved to recommend Kris #6 to the House of Delegates.

202.1.1 G (6) A swimmer's valid <u>club</u> affiliation and age <u>must shall</u> be displayed after the name <u>on the heat sheet or</u> in the meet program.

Rationale: "Shall" is the primary term used throughout the rule book. Updating the language for consistency.

Part 2 Reorganization was unanimously rejected and is not being recommended to the House of Delegates.
