Minutes

The meeting was called to order at 8 pm, Eastern time.

- MSA to reconsider L 2 (unanimous). Motion to amend L 2 to replace the words "if applicable" with the phrase "unless that individual is registering as a member of College Club Swimming, in which case the entire fee is allocated to USMS national operations." Motion passed (unanimous). MSA to recommend L 2 as amended (unanimous).
- 2. MSA to reconsider L 3 (unanimous). Motion to amend L 3 to the same phrase as in L2. Discussion concluded that this phrase was not applicable to College Club Swimming club fees. Motion was withdrawn. Motion to amend L 3 to delete the words "if applicable". Motion passed (unanimous). MSA to recommend L 3 as amended (unanimous).
- 3. MSA to reconsider L 8 (unanimous). Motion to amend L 8 by deleting the word "club". Motion passed (unanimous). MSA to recommend L 8 as amended (unanimous).
- 4. MSA to reconsider L 20 (unanimous). Motion to amend L 20 to clarify the language by repeating the word "national" to read, "Membership registration, national sanction, and *national* recognition fees shall be established by the House of Delegates." Motion passed (unanimous). MSA to recommend L 20 as amended (unanimous).
- 5. MSA to reconsider L 11 (unanimous). Motion to amend L 11 by correcting the reference to: 202.1.1(E). Motion passed (unanimous). MSA to recommend L 11 as amended (unanimous)
- 6. The document "Legislation 101" was discussed. It was determined that the document needed more revisions. The motion to approve the document was withdrawn.
- 7. Meeting adjourned at 8:56 p.m. Eastern time.

The allocation between national operations and LMSCs shall be established by the House of Delegates.
